Note: Data given on offences is for out of court sanctions (excluding those cancelled) and for court prosecutions. The Home Office reports that North Wales, South Wales, Gwent, North Yorkshire, Nottinghamshire and Derbyshire do not record all outcomes on the PentiP system. The Home Office also reports that camera detected offences for Dyfed-Powys, Gwent and South Wales are all reported under South Wales and so cannot be provided for the individual police service. In 2019, South Wales reported 28,199 camera detected speed limit sanctions. See overleaf for data sources.
